Main hazards: Flammable.

3. COMPOSITION / INFORMATION ON INGREDIENTS

4. FIRST AID MEASURES (SYMPTOMS)

- Skin contact:** There may be irritation and redness at the site of contact.
Eye contact: There may be irritation and redness. The eyes may water profusely.
Ingestion: There may be soreness and redness of the mouth and throat. May cause dizziness.
Inhalation: There may be irritation of the throat with a feeling of tightness in the chest. Drowsiness or mental confusion may occur.

4. FIRST AID MEASURES (ACTION)

- Skin contact:** Wash immediately with plenty of soap and water. Consult a doctor.
Eye contact: Bathe the eye with running water for 15 minutes. Consult a doctor.
Ingestion: Wash out mouth with water. Do not induce vomiting. Consult a doctor.
Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

5. FIRE-FIGHTING MEASURES

- Extinguishing media:** Do not use water. Alcohol resistant foam. Carbon dioxide. Dry chemical powder. Use water spray to cool containers.
- Exposure hazards:** Extremely flammable. Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide.
- Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6. ACCIDENTAL RELEASE MEASURES

- Personal precautions:** Refer to section 8 of SDS for personal protection details. Eliminate all sources of ignition.
- Environmental precautions:** Do not discharge into drains or rivers.
- Clean-up procedures:** Do not use equipment in clean-up procedure which may produce sparks. Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

7. HANDLING AND STORAGE

- Handling requirements:** Ensure there is sufficient ventilation of the area. Do not handle in a confined space. Smoking is forbidden.
- Storage conditions:** Store in cool, well ventilated area. Keep away from sources of ignition. Keep away from direct sunlight. Ensure lighting and electrical equipment are not a source of ignition.
- Suitable packaging:** Must only be kept in original packaging.
